Phase 1: Strengthening the Foundation and Planning for Change complete

As outlined in the Implementation Plan, the Aurora College transformation began in October 2018 and is structured around three phases. Each phase helps to ensure work is done in the right order and at the right time of the multi-year transformation process.

Phase 1 of the transformation was focused on strengthening the foundation and planning for change. Phase 1 projects were wide-ranging and driven by the hard work of faculty and staff at Aurora College. Aurora College working groups and project teams reached more than 45 critical and key milestones across five areas: Academic Program Management, Accountability, Governance, Operations, and Recruitment and Retention of Students.

All critical milestones and the majority of key milestones for Phase 1 have been completed. Through ongoing planning and review of progress, the decision was made to shift a number of key milestones to a later date. This is a normal part of project management, with key milestone dates changing due to either a change in the scope of work that required more time or a change in sequencing that required other projects to be completed in advance. Updates on past and future critical and key milestones can be found on the Aurora College Transformation website.

In addition to project work, engagement with co-investments partners has been gaining momentum, with the Government of Canada recognizing the importance of transforming Aurora College into a polytechnic university through a commitment of \$8 million in Budget 2021. Ongoing engagement with potential co-investment partners will continue to be critical to the success of the polytechnic university moving forward.

The work of Phase 1 culminated in the passing of *Bill 30: An Act to Amend the Aurora College Act*. The changes presented in Bill 30 will result in a new governance system that will help to ensure Aurora College is effective, efficient and sustainable. Aurora College will be better positioned to identify and respond to the needs of Northern residents, and do so at arm's length from government. Changes stemming from Bill 30 will be implemented in the spring of 2022 and provide a strong foundation for Phase 2 that will be focused on transformational change.
