Productive Choices



All applicants will continue to be enrolled in the Wellness: Self-Care Productive Choice.

Applicants will not need to sign a productive choice agreement or be required to report monthly on their productive choice.

All NWT residents are encouraged to continue practicing physical distancing and self-care in an effort to reduce the spread of COVID-19.

Seniors/Elders and Persons with Disabilities do not have to participate in Productive Choices.

Income



Earned Income

As of November 1, 2020 you will be required to report **all earned income** each month. Earned income will continue to be counted in your monthly assessments and all available exemptions will apply.

Note: All Income Assistance applicants who received earned income between March 1, 2020 and October 31, 2020 will be required to provide pay stubs or verification of earned income no later than January 15, 2021 to continue to receive benefits.

Unearned Income

As of November 1, 2020 all unearned income, known as gifts, from family and friends will be counted in your monthly assessments.

You will be required to declare this income when you apply.

Also, the **NEW** Canada Recovery Benefits for Workers will be counted in your monthly assessments. These benefits include:

- Canada Recovery Benefit
- Canada Recovery Sickness Benefit
- Canada Recovery Caregiving Benefit

Note: Applicants will be required to provide verification of all income received each month.

Reporting



Applicants are encouraged to discuss with their Client Services Officer what their reporting requirements will be as of November 1, 2020. Reporting will either be required on a monthly basis or for those that are being payrolled, either on 3, 6 or 12 month periods.

Monthly Reporting

Applicants will be expected to provide a completed Form A - Reporting Form **each month**, along with all supporting documents such as bank statements, pay stubs, utility invoices etc. to their Client Services Officer to receive benefits.

Note: Applicants with an expired Statement and Authorization will be required to submit a completed Application for Income Assistance.

Payroll

Applicants who qualify for payroll will be contacted by their Client Services Officer and must complete a Payroll Reporting Agreement.

New Applicants

New applicants will be required to submit a completed Application for Income Assistance along with supporting documents as required by their Client Services Officer.
