Introduction to the Guide

The “*Guide to Sessions of the Council of the Northwest Territories and Legislative Assembly of the Northwest Territories*” provides a historical overview to the political boundaries of the Northwest Territories, the evolution of its governance from Council to Legislative Assembly, a listing of all the Sessions of the Council and Legislative Assemblies, and the related holdings of the NWT Archives for research and reference purposes.

As the administrative history outlined below indicates, the structure and composition of the Territorial Council and later the Legislative Assembly of the Northwest Territories have changed over time. As a result, the numbering systems used for the Councils/Assemblies and Sessions have also changed. This list begins in 1921 when the first Council meetings were held after the creation of the Provinces of Alberta and Saskatchewan. Researchers looking for earlier records should consult the Provincial Archives of Saskatchewan, Alberta Legislative Library, and Saskatchewan Legislative Library.

From 1921-1951, the Sessions are numbered continuously for each meeting of the Council, with a few aberrations for Special sessions. In 1951, the Councils begin to be numbered and the session numbering system resets to one. Sessions are thereafter numbered continuously regardless of the Council’s number. There is also a parallel session numbering system in effect which makes use of the year the session is held in and the number of the session within that year. In 1979 the numbering system is revised again, with the Council (now known as the Assembly) number continuing from the previous system, but the sessions being numbered from one within in each Assembly. The parallel session numbering system using the year and session number within the year persists until the early 1990s.

The purpose of this Guide is to make clear these various numbering systems and how they correspond to individual meetings or periods of meetings, as well as to provide additional information, such as the dates and location of the session and where interested researchers can find records of the Session in holdings of the Northwest Territories Archives (NWTA). The final column of the table lists the reference numbers of accession containing records from that session. All the records are found within the Legislative Assembly fonds (322). Researchers are encouraged to search the NWTA online catalogue (<https://gnwt.accesstomemory.org/>) for additional information on the records available for each session, the accession in which records of interest are located, and specific file numbers.

The records available for each session also vary over time. The earliest sessions (1921-51) are documented only with summary minutes, and incomplete sets of agendas, sessional papers and reports, and complied ordinances. Records of the 1st to 8th Councils include Debates and incomplete sets of Commissioners’ Opening Addresses, Sessional Papers, Recommendations to Council, Information Items, Bills, Motions, Questions and Returns, and Tabled Documents. Records of the 9th to 19th Assemblies include Hansard, Votes and Proceedings, Addresses, Bills, Tabled Documents, Committee Reports, Motions, Petitions, and Questions and Returns, with nearly complete sets from the 10th Assembly onward.

Introduction au guide

Le *Guide des sessions du Conseil et de l'Assemblée législative des Territoires du Nord-Ouest* donne un aperçu historique des frontières politiques et de l'évolution de la gouvernance (passage d'un Conseil à une Assemblée législative) aux Territoires du Nord-Ouest ainsi qu'une liste de toutes les sessions législatives et de tous les fonds connexes des Archives des TNO à des fins de recherche et de référence.

Comme l'indique l'historique administratif ci-dessous, la structure et la composition du Conseil territorial, puis de l'Assemblée législative des Territoires du Nord-Ouest, ont changé au fil du temps. Les systèmes de numérotation des conseils et des assemblées ont également été modifiés, à l'instar de ceux des sessions. Cette liste commence en 1921, lorsque les premières réunions du Conseil ont eu lieu à la suite de la création des provinces de l'Alberta et de la Saskatchewan. Les chercheurs souhaitant obtenir des documents plus anciens devraient donc consulter les Archives provinciales de la Saskatchewan ainsi que les bibliothèques de l'Assemblée législative de l'Alberta et de la Saskatchewan.

De 1921 à 1951, les sessions sont numérotées de manière continue pour chaque réunion du Conseil, à l'exception de quelques aberrations pour les sessions extraordinaires. Les Conseils commencent à être numérotés à partir de 1951 et le système de numérotation des sessions revient alors à zéro. Par la suite, les sessions sont numérotées de manière continue, quel que soit le numéro du Conseil. Les sessions disposent également d'un système de numérotation parallèle composé de l'année de la session et du numéro de la session dans l'année en cours. En 1979, le système de numérotation est à nouveau révisé, le numéro du Conseil (désormais appelé Assemblée législative) est identique à celui du système précédent, mais la numérotation des sessions repart de zéro à chaque Assemblée. Le système parallèle de numérotation des sessions consistant à utiliser l'année et le numéro de session dans l'année en cours perdure jusqu'au début des années 1990.

L'objectif de ce guide est de clarifier ces différents systèmes de numérotation et la façon dont ils correspondent à des réunions individuelles ou à des périodes données, ainsi que de fournir des informations supplémentaires aux chercheurs, telles que les dates et le lieu de la session ou l'endroit où les personnes intéressées peuvent trouver ces documents aux Archives des Territoires du Nord-Ouest. La dernière colonne du tableau indique les numéros de référence des acquisitions contenant des documents pour une session donnée. Tous les documents sont disponibles dans les fonds de l'Assemblée législative (322). Les chercheurs sont encouragés à consulter le catalogue en ligne des archives (https://gnwt.accesstomemory.org/?sf_culture=fr) pour obtenir des renseignements supplémentaires sur les documents disponibles pour chaque session, le fonds dans lequel ils se trouvent et les numéros de dossier spécifiques.

Les documents disponibles varient également dans le temps pour chaque session. Les premières sessions (1921-1951) ne sont documentées que par des procès-verbaux sommaires, des ensembles incomplets d'ordres du jour, de documents et de rapports de session, et des ordonnances exécutées. Du 1^{er} au 8^e Conseil, les documents archivés comprennent les débats et des ensembles incomplets d'allocutions d'ouverture des commissaires, de documents parlementaires, de recommandations au Conseil, de points d'information, de projets de loi, de

motions, de questions et réponses connexes, et de documents déposés. De la 9^e à la 19^e Assemblée, les documents comprennent le hansard, les procès-verbaux, les allocutions, les projets de loi, les documents déposés, les rapports des comités, les motions, les pétitions et les questions et les réponses connexes. À partir de la 10^e Assemblée, les ensembles de documents sont quasiment complets.

Administrative History of the Governance of the Northwest Territories

1870-1905

The original North West Territories were created in 1870 when the Hudson's Bay Company sold to the British Government all the lands which it governed under the letters patent of Charles II. These lands were immediately transferred to the Government of Canada. On June 22, 1869, the Dominion government of Canada had passed An Act for the temporary government of Rupert's Land and the Northwest Territory in preparation for the transfer of control of these lands. This Act provided for a lieutenant governor, who was to set up a council of 7 to 15 in the administration of affairs. The lands included all the country drained by the rivers flowing into Hudson Bay including most of Saskatchewan and Alberta, part of Manitoba and the Keewatin District of Nunavut. It did not at that time include the greater part of the Arctic, to which the United Kingdom had some claim arising from the various naval expeditions of the early nineteenth century. Although the Hudson's Bay Company abandoned its jurisdiction in 1870, it retained its trading posts and expanded its commercial activities into other parts of Canada. In 1880 the British Government transferred any rights which it had over the Arctic Islands (which were still not completely explored or mapped) to the Canadian Government.

In 1875, the North-West Territories Act was passed, providing for a resident Lieutenant-Governor and an appointed council of not more than five people. A provision allowed for electoral districts of not more than 1000 square miles and not less than 1000 people. At such time as there were 21 electoral districts, the Council would become a Legislative Assembly. This number was surpassed in 1888. The Territories were governed by English law as it existed at the time of the transfer to Canada. This was amended by a considerable body of Ordinances passed by the Council. Increasing demands for political independence led to the 1905 creation of the Provinces of Saskatchewan and Alberta and the northward extension of the Province of Manitoba.

1905-1921

The remaining Northwest Territories were constituted by an Act of the Canadian Parliament (4 & 5 Edw.VII, c. 27) in 1905. This provided for the appointment of a Commissioner and a nominated Council of four. A Commissioner for the Territories was appointed in August 1905 but for the next fifteen years the Commissioner ruled without the assistance of a Territorial Council. The Commissioner had sole Executive authority for the Government of the Northwest Territories subject to instructions that he was given by the Minister of Indian and Northern Affairs or the Governor in Council.

The two Commissioners during this period were Frederick White (1905 - 1919), who was also Comptroller of the Royal North West Mounted Police, and N.W. Cory (1919 - 1930), who was Deputy Minister of the Interior. The entire administration of the Territories was therefore, in Ottawa. Administration of the Territories was the responsibility of the Federal Minister of the Interior, to whom both the Commissioner of Police and the Commissioner of the Territories reported. The population of the Northwest Territories was very sparse in 1905 and the northern

islands still largely unexplored. It was not until 1911 that the first complete census was organized throughout the area. Since the area to be covered was vast, administration was limited to essentials, and these duties were of a municipal type - the relief of the destitute, care of the sick and the prevention of crime. The police posts and patrols provided the local personnel and they were supplemented by the voluntary efforts of missionaries and Hudson's Bay Company post managers.

The police reported to the Mining Lands and Yukon Branch of the Ministry of the Interior (the Mines Branch until 1909) in all matters concerning the Territories. For the administration of justice, the relevant ordinances of the old North West Territories were applied. A few amendments and additions were made by Order in Council at the end of this period, but a decision of the Department of Justice in April, 1921 stated that these were invalid because no Council existed. Any justices appointed for the original Territories were apparently considered capable of hearing cases, and no new justices were appointed. Appeals could be made from their decisions to the nearest Provincial Court of Appeal (Acts 6 & 7 Edw. VII, c. 32 and 7 & 8 Edw. VII, c. 49).

1921-1951

Canada's interest in its Arctic territories has been stimulated from time to time by geological discoveries (gold, other metals and oil) or by war. Each of these events has been followed by changes (and an increase in volume) of administrative and judicial activity. The first of these changes occurred at the end of the First World War when oil was discovered at Norman Wells. The need to provide for the registration of land and mining claims in the Mackenzie District and for the amendment of the old Ordinance led to the appointment of the first Territorial Council on 20 April, 1921.

The councillors (all senior members of the Department of the Interior, including the Commissioner of the Royal Canadian Mounted Police) met only once, on 28 April 1921, to hear a report by their Acting Secretary, Mr. O.S. Finnie. A party of twenty-two employees had been sent from Ottawa to Fort Smith (just across the Alberta border) to organize a government office for the Mackenzie District. The councillors expressed considerable doubt about the legal position of the administration.

The Ordinances needed revision and the validity of some was referred to the Department's legal advisers. Consideration was given to raising territorial revenue by charging fees for trading and business licences. It was agreed to ask for an amending Act to increase the number of councillors to six. The amending Act (11 & 12 Geo. V, c. 40) was passed on 13 June 1922 and the new Council met on the next day in a flurry of legal activity. The City of Ottawa lawfully became, for the first time, the capital of the Northwest Territories. The Entry and the Beverage Ordinances (issued by the Commissioner's sole authority) were declared ultra vires, and various official duties relating to the Territories were re-assigned.

A Northwest Territories and Yukon Branch was organized within the Department of the Interior with Mr. O.S. Finnie as its Director. He, and the Superintendent General of Indian Affairs became the two new councillors added by authority of the 1922 Act. By agreement with the

Quebec Government, the Branch was also responsible for New Quebec and its Indigenous people. In 1936, when the Department of the Interior was abolished, the Branch and its duties were transferred to the Department of Mines and Resources. It was renamed the Bureau of Northwest Territories and Yukon Affairs and placed in the Lands, Parks and Forests Branch of the Department. In 1950 and 1951 the duties of the Bureau were rearranged and it was renamed several times.

Until the outbreak of the Second World War, the Territories continued to be governed in the same fashion as before 1922. The police (now re-organized as the Royal Canadian Mounted Police) provided the local administration with assistance from the handful of local territorial government employees as well as the missionaries and H.B.C. post managers. However closer control was maintained by the Ottawa office and the Territorial Council. Increased efforts were made to list and control the Indigenous peoples. This in turn led to further demands for welfare services and an extension of law enforcement. Progress was slow. It was not until 1942, as a result of wartime problems, that Inuit were listed and issued with disc numbers. For many years the only magistrate in the Territories was an Alberta provincial judge who made an annual visit to the Territories.

The discovery of gold in the Great Slave Lake area was followed by the Second World War and further development of the oil resources of Norman Wells. Although these events did not produce any legislative and administrative changes, their impact on the Northwest Territories is clearly shown by the increased number of meetings of the Council and the increased volume of business generated by the administration. During almost the whole of this period the appropriate Deputy Minister acted as Commissioner: W.W. Cory (1919-31), H.H. Rowatt (1931-34), Dr. Charles Camsell (1936-46), and Dr. H.L. Keenleyside (1947-50). In 1935 Mr. R.A. Gibson, the Deputy Commissioner, presided at meetings of the Council. All the members of the Council were Federal public servants, with the first northern resident only being appointed to the Council in 1947 (J.G. McNiven). However, by 1951 it was quite clear that this colonial style of government was unsuitable for the increased population and industrial activities of the Territories.

1951-1975

In 1951, the Northwest Territories Act was amended to permit three elected members to be included in the Council of eight and required Council to hold at least two sessions a year, one of them in the north. Further amendments increased the Council's legislative and financial powers. A fourth elected member was added in 1954, as Council membership rose to nine. The size remained the same until 1966, when the first electoral districts were created outside of the Mackenzie.

By 1955, Council could authorize the Commissioner to make agreements with the federal government, subject to Ottawa's approval and they could use a separate Northwest Territories revenue account, as long as a deficit was not created. The amendments also allowed the Commissioner to control some public lands, created a Territorial Court, and repealed major part of the NWT Act so that territorial ordinances could take their place. In 1958, the Council

received the power to borrow money subject to federal approval and by 1960 the Council had the power to pass game laws affecting Dene and Inuit.

In 1960, the first members from outside the civil service were appointed. By 1964, four of the five appointees to the nine-member Council were from the private sector; the Deputy Commissioner remained as the only civil servant appointee to the Council. Separate offices for the Government of the Northwest Territories were created, the position of Commissioner became a full-time appointment, and the task of building a headquarters that would eventually move north began. In 1965, the naming of the Deputy Commissioner became a separate Governor-in-Council appointment and his duties were made full-time. The first Inuit member of Council was also appointed and the following year (1966), the Council's elected membership increased from four to seven as electoral districts were created in the Keewatin, High Arctic and Eastern Arctic. The Commissioner-in-Council was given authority to set qualifications for electors and candidates, and a separate Consolidated Revenue Fund for the Northwest Territories was set up within the Consolidated Revenue Fund of Canada.

The Carrothers Report, also released in 1966, recommended that northern residents be given a greater degree of self-government, but felt that the Northwest Territories should not be divided at that time. In 1967, the territorial government moved to the new capital of Yellowknife, as the Report had recommended. In 1970, the Northwest Territories Act was amended again and Council's elected membership increased to 10 and the appointed membership decreased from five to four. Council's term of office was increased to four years from three and the Commissioner-in-Council was authorized to set members' indemnities and allowances and the period in which Ottawa could disallow territorial legislation was cut from two years to one. The Seventh Council, which included the first elected Dene member, two Inuit members and a Métis member, took office early in 1971.

1975-1999

The first fully-elected Council since 1905 took office in 1975. This Council was given the authority to elect its own Speaker and to name two elected members to the Executive Committee (a third was added a year later). In 1979, the NWT Council was renamed the Legislative Assembly. As the chief political body it is composed of non-partisan elected officials representing all residents of the Northwest Territories.

Throughout the 1970s and 1980s, the gradual transfer of power from the Commissioner to elected ministers was evident. In 1980, the Commissioner was still the formal head of government in the Northwest Territories and chaired the Executive Committee and the Financial Management Board. The Commissioner also had line responsibility for the Department of Finance and the Department of Information. In succeeding years although the authority of the Commissioner, as defined by the NWT Act remained unchanged, executive members to the Assembly began to assume increased responsibility for departmental and executive functions.

1984 marked the first time that an elected Government Leader was chosen by the full caucus, and the first time that all eight of the Executive Council members were elected. The

Commissioner continued to chair the Executive Council, with the Government Leader taking the role of deputy chairman. With the devolution of portfolios to elected ministers of the Executive Council, the Commissioner ceased sitting with members of the Legislature in committee of the whole. These steps represented recognition by Ottawa of the increased political maturity of the Government of the Northwest Territories and signified a process leading towards full responsible government. In 1986, the Commissioner turned over the chairmanship of the Executive Council to the Government Leader. With this symbolic act, the Northwest Territories, in practice, achieved responsible government, as elected ministers took full responsibility for the conduct of government.

Another significant change occurred in 1993 when the new Legislative building in Yellowknife was opened. Prior to that time, the Legislative Assembly operated from temporary and leased premises.

1999-present

Although the question of division of the Northwest Territories had been considered previously, in 1982 a plebiscite was held with the result in favour of creating Nunavut. Various groups, including the Constitutional Alliance, Nunavut Constitutional Forum, Western Constitutional Forum, Commission for Constitutional Development (Bourque Commission), and Constitutional Development Steering Committee, worked on the constitution and structure of the resulting eastern and western territories throughout the 1980s and 1990s. Meanwhile, the Tungavik Federation of Nunavut and the federal government negotiated the Inuit land claim. In 1992, a plebiscite on the boundary for division was held and the proposed line passed. In 1993, the Canadian Parliament passed both the Nunavut Lands Claims Agreement Act and the Nunavut Act and on April 1, 1999, Nunavut was officially created. The remaining western territory retained the name “Northwest Territories”. With the Nunavut MLAs gone, the size of the Legislative Assembly was reduced to 19 representatives.

To the present day, the Legislative Assembly of the Northwest Territories continues to operate on a consensus basis, with all members being elected as independents. During the territorial leadership meeting held after a general election, the members elect the Speaker, the Premier, and six other Cabinet members from amongst themselves. The remaining eleven regular members function as an unofficial opposition.
