



# Right from the Start

## 2019-2020 Early Childhood Development Scholarships

---

The Department of Education, Culture and Employment (ECE) *Right from the Start Early Childhood Development Framework and Action Plan* has committed to increasing the number of qualified Early Childhood Development (ECD) professionals in licensed child care facilities in the Northwest Territories (NWT).

**Scholarships of \$5000 each** will be awarded to NWT students to help full-time<sup>1</sup> college and/or university students offset the costs of attending an accredited<sup>2</sup> post-secondary institutions to complete Diploma or Degree programs with a direct focus in Early Childhood Development studies during the 2019-2020 academic year. Students enrolled in online programs are not eligible.

Applications will be judged according to criteria outlined in the application package.

Preference will be given to applicants who meet the additional criteria:

- applicants that have indicated they plan to return to the NWT to pursue a career in early childhood development;
- applicants from small NWT communities; and,
- applicants who are in their first year of study.

Applicants must ensure all information is complete and accurate and all requirements listed in the Part I of the application are submitted to the Department of ECE by the deadline.

Completed applications will include the following documents:

- Application Form (A, B & C)
  - Letter of Acceptance or Conditional Acceptance to diploma or degree program
  - Information on diploma or degree program
  - Proof of NWT Residency (2 pieces)
  - Copy of Academic Transcripts (if applicable)
  - Letter of Intent

### DEADLINE

Applications must be received by **5:00 P.M. MDT on September 16, 2019**, to be considered. It is the applicant's responsibility to ensure all required documentation is submitted and received prior to the deadline.

## PART I - ELIGIBILITY REQUIREMENTS

To complete your application, you must provide the following:

1. Completed Part II – APPLICATION FORM (A, B & C)
2. Letter of acceptance from a college or university detailing your studies in an Early Childhood Development focused Diploma or Degree program, specifying the date your studies begin, and the length of the program you are enrolled in. A letter of conditional acceptance is also acceptable. ECE staff may contact you after your program start date to confirm your attendance.
3. Information on the Diploma or Degree program. For example, this could include a brochure, or a print-out of a description of the program from the institution's website.
4. Proof of current NWT residency (legible copy of your NWT Health Card, General Identification Card, Driver's License). Must submit **two** proofs of residency documents **that will not be expired** before the application deadline.
5. A copy of your official or unofficial transcript from the previous academic year (not a requirement for students leaving high school and entering their first year of the Early Childhood Development Program). You must have an overall passing grade as determined by your postsecondary institution.
6. A letter of intent, approximately 1-2 pages, which includes all of the following elements:
  - a. Your career plan and goals, including what you plan to do when you have finished your program;
  - b. Why you chose to pursue a career in Early Childhood Development;
  - c. How you expect this diploma/degree program to benefit you and your career goals;
  - d. Why you should be chosen as a recipient of an Early Childhood Development scholarship;
  - e. Where you aim to live and work after graduation.

Priority will be given to students enrolled in their first year of studies, as well as students that have not previously received a scholarship. Preference will be given to those applicants that have indicated they plan to return to the Northwest Territories to pursue a career in early childhood development. All decisions of the selection committee are final.

Once the scholarship selection committee has made its decision and awarded the available scholarships, you will receive by email its decision concerning your application.
