# LOAN REPAYMENT INCENTIVES FOR NWT STUDENT LOANS INFORMATION SHEET

The Student Financial Assistance (SFA) Program offers loan repayment incentives to encourage northern students to return and reside in the Northwest Territories (NWT) and to help alleviate student debt. Students that have received a student loan under the *NWT Student Financial Assistance Act* and Regulations may apply for loan remission, zero percent interest, and/or the northern bonus.

## General Eligibility:

- Received remissible loan(s) and/or repayable loans(s) through NWT SFA;
- Ceased full-time studies for a period of 6 months or longer;
- Enter into a Consolidated Loan Notice;
- Actually reside in the NWT in the sense of eating, sleeping and carrying on your normal activities for a minimum period of three (3) months; and
- Submit an Application for Loan Repayment Incentives by the applicable deadline(s).

## 1) Loan Remission Eligibility:

- Meet all general eligibility criteria;
- Received remissible loan(s);
- Successfully completed the minimum required percentage of a 100% full course load for each semester you received a remissible loan; and
- Apply twice a year by **April 15th** and **October 15th**.

The rate of remission (forgiveness) is based on the community (zone) you reside in; the following is a breakdown of the rates:

Zone	Communities	Six (6) Month Forgiveness Rate
1	Yellowknife (including N'dilo and Dettah)	\$3,000 \$16.44/day
2	Fort Simpson, Fort Smith, Hay River, Hay River Reserve, Inuvik and Norman Wells	\$4,000 \$21.92/day
3	Aklavik, Behchokò, Colville Lake, Délljne, Enterprise, Fort Good Hope, Fort Liard, Fort McPherson, Fort Resolution, Gamètì, Jean Marie River, Kakisa, Łutselk'e, Nahanni Butte, Paulatuk, Sachs Harbour, Trout Lake, Tsiigehtchic, Tuktoyaktuk, Tulita, Ulukhaktok, Wekweètì, Whatì and Wrigley	\$6,000 \$32.88/day

## 2) Zero Percent Interest Eligibility:

- Meet all general eligibility criteria;
- Received remissible and/or repayable loan(s);
- Apply twice a year by **April 15th** and **October 15th**.

### 3) Northern Bonus Eligibility:

- Meet all general eligibility criteria;
- Received remissible and/or repayable loan(s);
- Student loan account is up to date and in good standing;
- Ceased full-time studies for a period of 12 consecutive months prior to applying;
- Actually resided in the NWT for 12 consecutive months prior to applying; and
- Apply once a year by **April 15th** or **October 15th**.

The Northern Bonus will be applied to your student loan account up to a maximum of \$2,000 per year. NWT residents are eligible to receive up to a maximum of \$10,000 in a lifetime.

### Vacation Policy

- Occasional absences totaling not more than a maximum of 3 consecutive months in a calendar year are permitted and do not need to be reported.
- Absences beyond 3 months in a calendar year will result in loan remission and/or zero percent interest ineligibility.
- Absences beyond a maximum of 3 months are permitted in certain circumstances at the discretion of the Deputy Minister.
- If you accept any employment (full-time or part-time) while vacationing, you will be ineligible for loan remission and/or zero percent interest.
- All SFA files are subject to verification and audit at any time.
- If audited, you will be required to submit documentation to verify your NWT residency.

- Provide information or documents to verify my initial and continued eligibility for the Loan Repayment Incentives within 20 days of request.

#### 3. I understand that:

- If I make a false or misleading statement, I may be required to repay all Loan Repayment Incentives received and/or be denied future Loan Repayment Incentives and or may be subject to criminal prosecution.
- I may have to immediately return any SFA received in prior years, current or future years if there were/are changes to my personal information that would result in my being ineligible for the Loan Repayment Incentives.
- SFA will contact other agencies to verify the information I have provided as part of determining my initial and continued eligibility for the Loan Repayment Incentives and to detect fraud. These agencies may include, but are not limited to the following: other GNWT departments, federal, territorial, municipal or Aboriginal governments including driver and vehicle licensing programs, Employment and Social Development Canada including Record of Employment and Employment Insurance, Parental and Maternity Benefits, Canada Revenue Agency and Canada Citizenship and Immigration, housing management bodies, financial institutions, airline and travel agencies, landlords, educational institutions and employers.

#### 4. I consent to the release of:

- Personal information to the SFA program by those agencies listed in 3.c. above to verify any personal information provided to determine my initial and continued eligibility for the Loan Repayment Incentives. I understand that if I consent to the release of my personal information to third parties, that this consent is valid until I advise the Manager, Divisional Financial Service in writing that I withdraw my consent.

#### 5. I consent to the release, by the Canada Revenue Agency, to an official of the SFA program, of information from my income tax returns, and, if applicable, other required taxpayer information about me whether supplied by me or by a third party. The information will be relevant to, and used solely for the purpose of determining and verifying my eligibility, entitlement for and general administration and enforcement of the Loan Repayment Incentives under the *Student Financial Assistance Act*, *Regulations* and *ATIPP* and will not be disclosed to any other person or organization without my approval.
